**ARTICLES OF ORGANIZATION
OF
WRW INVESTMENTS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be WRW INVESTMENTS, LLC (the "Company").

ARTICLE II - ADDRESS

The initial street and mailing address of the Company shall be: 14366-B Harbour Landings Drive, Fort Myers, Florida 33908.

ARTICLE III - REGISTERED AGENT & REGISTERED OFFICE

The name and the Florida street address of the initial registered agent of the Company shall be: AARON A. FARMER, P.L., 999 Vanderbilt Beach Road, Suite 606, Naples, Florida 34108.

ARTICLE IV - MANAGEMENT

The Company shall be managed by a Manager and is, therefore, a manager-managed company. The names and the addresses of the initial Manager of the Company are:

ARTICLE V - MEMBERSHIP CLASSES AND VOTING RIGHTS

The Company shall have two classes of Membership Interests, Class A and Class B. Ten Percent (10%) of the Membership Interests shall consist of Class A and Ninety Percent (90%) shall consist of Class B. Except as provided in the Operating Agreement Class A Membership Interests shall have the right to vote and Class B Memberships Interests shall not include the right to vote. The economic rights to receive distributions and return of capital shall be the same for the Class A and Class B. Therefore, the only distinction between Class A and Class B is the right to exercise voting rights.

NOW THEREFORE, the undersigned has signed these Articles of Organization for the Company and acknowledges them to be his act this 26th day of March, 2009.


