FIRST: The name of the Limited Liability Company is: Novia Group LLC (the "Company").

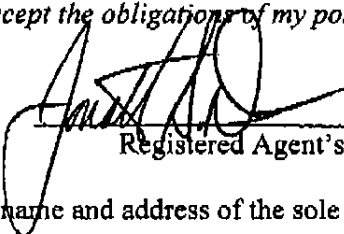

FIFTH: These Articles of Organization shall be deemed to be the operating agreement of the Company, unless and until the members shall have otherwise adopted additional or inconsistent provisions in connection with any matters permitted to be addressed in an operating agreement.

SIXTH: Unless sooner dissolved in accordance by Act, the duration of the Company shall be perpetual.

SEVENTH: The Managing Member of the Company may transfer his, her or its interest in the Company in accordance with the provisions of the Company's operating agreement, by-laws and the Act.

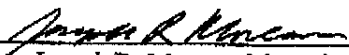
EIGHTH: A manager shall not be personally liable to the Company or its members for damages for any breach of duty in such capacity as a manager, except for damages resulting from actions or omissions by such manager, as to which there shall have been a judgment or other final adjudication that establishes that such acts or omissions were in bad faith, involved intentional misconduct or a knowing violation of law, or that such manager personally gained a financial profit or other advantage to which he or she was not legally entitled, or that with respect to a distribution subject of Section 608.428 of the Act, such manager's acts were not performed in accordance with subdivision two of Section 608.426 of the Act. Neither the amendment nor the repeal of this Article shall eliminate or reduce the effect of this Article in respect of any matter occurring, or any cause of action, suit or claim that, but for this Article, would accrue or arise, prior to such amendment, repeal or adoption of an inconsistent provision. This Article shall neither eliminate nor limit the liability of a manager for any act or omission occurring prior to the adoption of this Article.

NINTH: The Company shall have the power to indemnify, to the fullest extent permitted by the Act, as amended from time to time, and not inconsistent with the public policies of the state of Florida, all persons who it is permitted to indemnify pursuant to the Act.

TENTH: These Articles of Organization shall be effective upon filing.

ELEVENTH: The purpose of the Company is to engage in any lawful act or activity for which limited liability companies may be organized under the Act.
