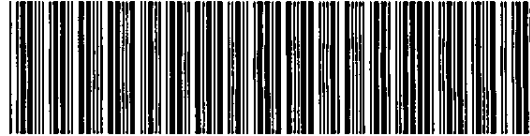

AGREEMENT

This Agreement is made and entered into on the 18th day of May, 2015 between Eutris A. Delancy ("Delancy") whose mailing address is 3805 SW Revere Court, Port St. Lucie, FL 34953 AND David Bernard ("Bernard") whose mailing address is P.O. Box 7701, Port St. Lucie, FL 34985.

1. **CONSIDERATION AND TERM OF AGREEMENT.** Delancy agrees to provide Bernard with the funds from Delancy Group Home, LLC ("Delancy Group Home") in order to set up one (1) group home ("New Group Home"). The funds shall be used for the set up of the New Group Home. Delancy Group Home shall continue to pay the monthly rent of the New Group Home until the New Group Home has an occupant, but no later than six (6) months from the date that the New Group Home is acquired.

In consideration of the above referenced, Bernard agrees to give back to Delancy, ten percent (10%) shares of Delancy Group Home, LLC.

2. **LIMITATION OF LIABILITY.** Delancy assumes no liability for loss, damage, or destruction of any kind to the New Group Home, whether due to fire, theft, or otherwise.
3. **INSURANCE.** Bernard agrees to insure the New Group Home at Bernard's cost and expense.
4. **LAW.** This Agreement shall be governed by the laws of the State of Florida.
