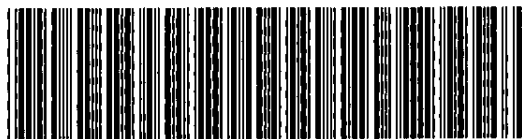

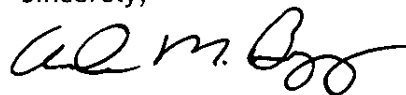

**ARTICLES OF ORGANIZATION  
OF  
BARFIELD & BRAGG, PLC**

ARTICLE 1 - NAME

The name of the professional limited liability company shall be Barfield & Bragg, PLC.

ARTICLE 2 - ADDRESS

The mailing address and street address of the principal office of the company is 1904 West Cass Street, Tampa, Florida 33606.

ARTICLE 3 - DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on June 1, 2009. The company's existence shall be perpetual or shall terminate or be dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE 4 - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida are Morgan Barfield and 1904 West Cass Street, Tampa, Florida 33606.

ARTICLE 5 - CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company the cash, property or services set forth in Exhibit "A."

ARTICLE 6 - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional contributions to the company only on the unanimous consent of all the members, or as provided in the regulations.

ARTICLE 7 - ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all of the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE 8 - MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or a manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business is continued by unanimous vote of all remaining members. *THE PURPOSE SHALL BE TO PRACTICE LAW.*

ARTICLE 9 - MANAGEMENT

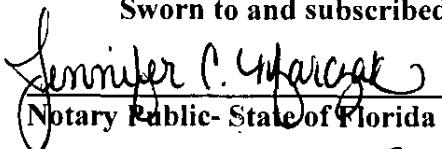
