ARTICLES OF ORGANIZATION OF BARFIELD & BRAGG, PLC

ARTICLE 1 - NAME

The name of the professional limited liability company shall be Barfield & Bragg, PLC.

<u>ARTICLE 2 – ADDRESS</u>
