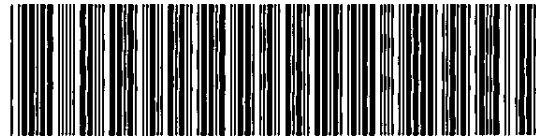



The name of the limited liability company is PEPE INVESTMENTS #2, LLC (hereinafter, the "Company").




