**ARTICLES OF ORGANIZATION
OF
DANA L. MANNER, P.L.**

**A PROFESSIONAL LIMITED LIABILITY COMPANY
ORGANIZED UNDER THE LAWS OF THE STATE OF FLORIDA**

The undersigned, Dana L. Manner, certifies the following for the purpose of becoming a professional limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. The undersigned further declares the following Articles of Organization shall serve as the authority to conduct the business of Dana L. Manner, P.L.

ARTICLE I. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the professional limited liability company shall be Dana L. Manner, P.L., and its principal office shall be located at:

ARTICLE II. PURPOSES AND POWERS

The purpose of Dana L. Manner, P.L. is to engage in providing professional services, specifically providing legal services such as providing legal representation, counsel and advice, and to otherwise engage in the general practice of law, as a professional limited liability company, and to carry out other services incident to the general practice of law or provision of legal services. The general practice of law is the sole and exclusive professional service to be rendered by Dana L. Manner, P.L. This professional limited liability company also shall have the power vested in it to own property, enter into contracts, and carry on any business necessary or incidental to the accomplishment or furtherance of the purposes of Dana L. Manner, P.L.

ARTICLE III. EXERCISE OF POWERS

All powers of Dana L. Manner, P.L. shall be exercised by or under the authority of Dana L. Manner, and the business and affairs of this limited liability company shall be managed under the direction of Dana L. Manner.

ARTICLE IV. MANAGEMENT

ARTICLE V. MEMBERSHIP RESTRICTIONS

The Managing Member, in his sole discretion, shall have the right to admit new members. Contributions required of new members shall be determined as of the time of admission to Dana L. Manner, P.L.

ARTICLE VI. CAPITAL CONTRIBUTIONS

Capital contributions in the amount of Ten Dollars cash (\$10.00), and other valuable consideration, shall be paid to Dana L. Manner, P.L. by its Managing Member. Additional contributions will be made as required for investment purposes, as determined in his sole discretion by the Managing Member.

ARTICLE VII. PROFITS AND LOSSES

(a) Profits

The Managing Member shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of Dana L. Manner, P.L.

(b) Losses

All losses that occur in the operation of the limited liability company business shall be paid out of the capital or profits of conducting the business of Dana L. Manner, P.L.

ARTICLE VIII. DURATION

This professional limited liability company shall exist until so long as Dana L. Manner maintains legal authorization to practice law in the State of Florida, or until dissolved in a manner provided by law, or as otherwise determined in his sole discretion by the Managing Member.

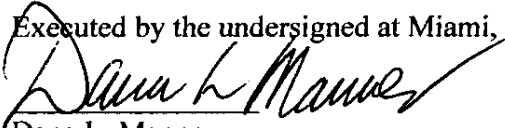

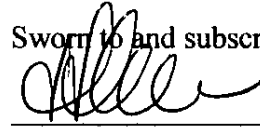

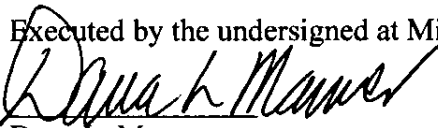
