ARTICLES OF ORGANIZATION OF DANA L. MANNER, P.L.

A PROFESSIONAL LIMITED LIABILITY COMPANY ORGANIZED UNDER THE LAWS OF THE STATE OF FLORIDA

The undersigned, Dana L. Manner, certifies the following for the purpose of becoming a professional limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. The undersigned further declares the following Articles of Organization shall serve as the authority to conduct the business of Dana L. Manner, P.L.

ARTICLE I. NAME AND PRINCIPAL PLACE OF BUSINESS
