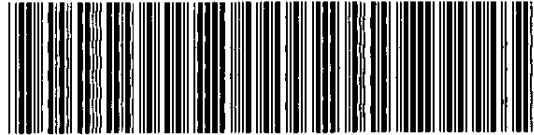



A Florida Limited Liability Company

ARTICLE 1  
NAME

The name of this limited liability company is ISOFA, LLC.
