### ARTICLES OF ORGANIZATION

OF

# LAKE NONA RESEARCH I, LLC

The undersigned, acting as the organizer of LAKE NONA RESEARCH I, LLC, under the Florida Limited Liability Company Act, Chapter 608, <u>Fla. Stat.</u>, adopts the following Articles of Organization:

#### ARTICLE I - Name:

The name of the limited liability company is Lake Nona Research I, LLC (the "Company").

#### ARTICLE II - Address:
