The undersigned, LE E. ROGERS, having legal authority to contract, hereby presents these Articles of Organization of WARWICK 411, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is as follows:

WARWICK 411, LLC

This limited liability company is referred to in these articles of organization as the "Company".

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the principal office of the Company is 411 Warwick Street, Gulf Breeze, FL 32561.

ARTICLE III - PURPOSES AND POWERS

This Company is organized for any legal and lawful purpose for which a limited liability company may be organized and may exercise all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act.

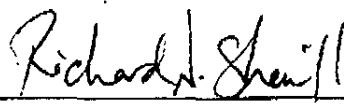
ARTICLE VII - AMENDMENT
