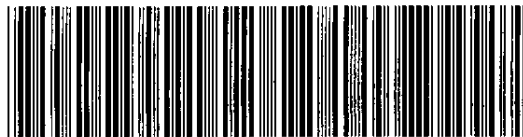

The undersigned, acting as the organizer of Lambert Lynn Event Studio, LLC, under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**Article I – Name:**

The name of the limited liability company is Lambert Lynn Event Studio, LLC (the “Company”).

**Article II – Address:**

The mailing address of the Company is 138 Rockhill Drive, Sanford, Florida 32771 and the street address of the Company is the same.

**Article III – Duration:**

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of the Operating Agreement for the Company.

**Article IV – Management:**

The Company is to be managed by its Member(s), unless and until one or more managers are appointed in accordance with the Operating Agreement of the Company, in which case the Company shall be managed by one or more managers. The managers shall be elected as described in the Operating Agreement.

**Article V – Admission of Additional Members:**

The Company shall admit new Members only upon the written consent of the then existing Members of the Company owning a majority of the outstanding percentage interest in the Company.

**Article VI – Adoption of Operating Agreement:**

The Company shall adopt an Operating Agreement for the Company, which Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization or Chapter 608, Fla. Stat.

## **Article VII – Initial Registered Agent and Office:**

The initial registered agent for the Company shall be Rebecca Bass and the street address of the Company's initial registered office is 138 Rockhill Drive, Sanford, Florida 32771.

Having been named as Registered Agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as Registered Agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties and I am familiar with and accept the obligations of my position as Registered Agent as provided for in Chapter 608, F.S.


## **Article IX – Amendments:**
