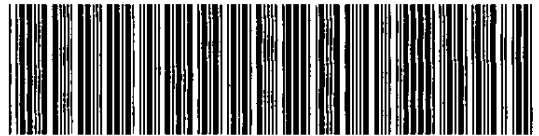

2. The Company was formed on March 30, 2009 and the document number of the Company is L09000032089.

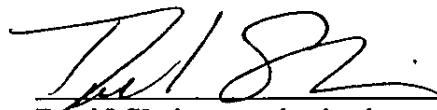
3. Article V of the Articles of Organization of the Company contains a misspelling of the managing member's first name, which should have been spelled as Derik and not Derek.
