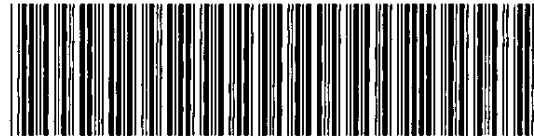

ARTICLES OF ORGANIZATION

The undersigned, Michael John Pearson, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be "THE BUG GUY PEST CONTROL, LLC".

ARTICLE IV - PURPOSE AND POWERS

To engage in the business of pest control, pest extermination and sterilization, including the use of such chemicals as the limited liability company or its subsidiaries may be licensed and permitted to use, the preparation of escrow reports and the making of inspections as required, and the servicing of properties in the matter of extermination and fumigation in all phases of the work of pest control in whatever respect the limited liability company or its authorized subsidiaries may be licensed to do. In addition the Company shall have all other powers allowed by law.

ARTICLE V - INITIAL MEMBERS

The name and address of the initial member of the company and his respective interests in the company is:

Any member shall have authority to bind the company.

#### ARTICLE VI - ADMISSION OF NEW MEMBERS

Except as otherwise agreed to in the operating agreement, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the operating agreement of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.


#### ARTICLE VII - MEMBER'S RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by majority vote of all the remaining members.

#### ARTICLE VIII - MANAGEMENT

The company shall be managed by a manager in accordance with the operating agreement adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.


