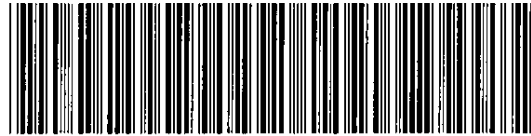

**ARTICLE I**  
**NAME**

The name of this Limited Liability Company is **CARTER JONES ROAD, LLC.**

**ARTICLE II**  
**DURATION**

All members agree to abide by the majority decision and agree to sign the amendments for the purpose of filing with the Florida Department of State.

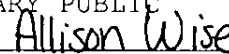
