**ARTICLES OF ORGANIZATION
FOR

The undersigned, acting as the organizer of TREASURED MOMENTS VIDEO PRODUCTIONS, LLC, under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is:

**ARTICLE II
INITIAL PRINCIPAL OFFICE ADDRESS,
