**AMENDED & RESTATED ARTICLES OF ORGANIZATION
OF

The Articles of Organization for this Limited Liability Company ("Company") were filed on April 06, 2009, and assigned Florida document number L09000033129. These Amended & Restated Articles of Organization were adopted on September 2, 2011 by the members pursuant to §608.411, Florida Statutes. Each amendment set forth in these Amended & Restated Articles of Organization was approved by the members in a vote sufficient for approval of the amendment. These Amended & Restated Articles of Organization supercede the original Articles of Organization, as amended.

Article I. Name
