# ARTICLES OF ORGANIZATION FOR **EXCLUSIVE MAYFAIR. L.L.C.**

#### **ARTICLE I - NAME**

The name of the Limited Liability Company is EXCLUSIVE MAYFAIR, L.L.C.

# **ARTICLE 11 - ADDRESS**

### ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The members of the Limited Liability Company shall be permitted to admit additional members upon approval of members owning one hundred percent (100%) of the outstanding Member Units of the Limited Liability Company. Likewise, there shall be no return of all or a portion of the contributed capital without the consent of One hundred Percent (100%) of the Members in interest.

#### **ARTICLE IX - DISTRIBUTION**

The purpose of the Limited Liability Company is to engage in one or more businesses and/or to invest and reinvest its assets. Accordingly, no distribution is contemplated. Notwithstanding the foregoing, the Board of Managers and one hundred percent (100%) of the members in interest may consent to a distribution. All distributions shall be in the form of insurance company annuity contracts with the respective members as the annuitant, unless the Board of Managers and one hundred percent (100%) of the members in interest consent otherwise.
