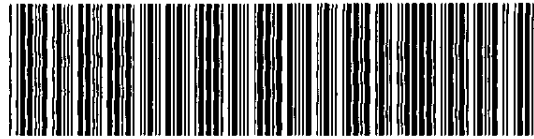

**ARTICLES OF ORGANIZATION
OF
Poppa Daddy's Classic Cars, L.L.C.
A Florida Limited Liability Company**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

ARTICLE 1 – Name: Poppa Daddy's Classic Cars, L.L.C.


