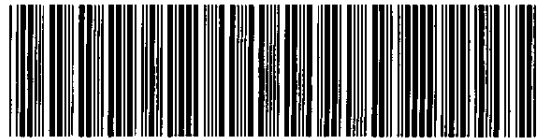

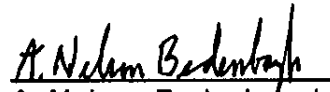
ARTICLE VI
