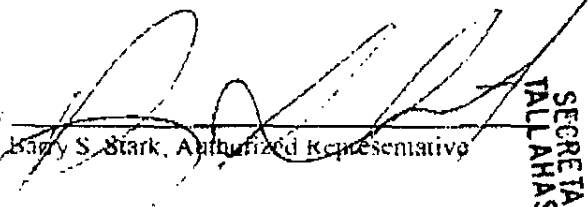
1. NAME. The name of the Limited Liability Company is B&B HOMECARE OF BROWARD, LLC (the "Company").
