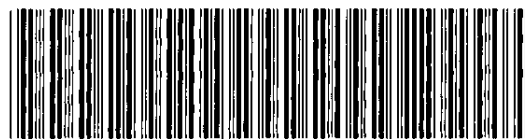

This limited liability company shall have a perpetual existence, unless dissolved according to law, commencing on the 10<sup>th</sup> day of April, 2009.




