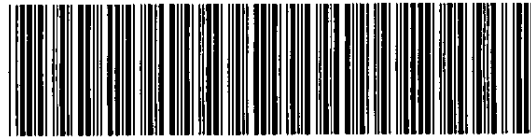

The undersigned, being authorized to execute and file these Articles of Amendment to Articles of Organization, hereby certifies that:

**FIRST:** These Articles amend the Articles of Organization of PF Insurance, LLC, a Florida limited liability company.

**SECOND:** The Articles of Organization were filed with the Florida Department of State on April 10, 2009.

**THIRD:** Pursuant to Section 608.411 of the Florida Statutes, PF Insurance, LLC amends its Articles of Organization by restating Article I of its Articles of Organization as follows:

Article I of the Articles of Organization is hereby amended by deleting the existing Article I and replacing it with the following:


**ARTICLE I
