The company used to be incorporated under my wife's name and when I incorporated under new articles irs is giving me the same tax id number due to same address and company name even though ownership different. So I was advised to become LLC. When I got on the website to check status - if it had dissolved I noticed to my surprise that someone had reinstated the articles and changed the principle address and registered agents names on 12/08/2008. I do not know these people, and have tried to contact them to see if it was an error on their part- but no carpet kingdom exists in celebration fla. And the address is the chamber of commerce and they said there is no carpet kingdom in that building. I had contacted you and a lawyer to advise me on what to do and was advised by both to voluntarily dissolve the corporation. It is my understanding that the articles could not be reinstated if I voluntarily dissolve.


