ARTICLES OF ORGANIZATION OF 4D Realty Group, LLC

The undersigned member(s), or authorized representative of a member, for the purpose of forming a Limited Liability Company pursuant to Chapter 608, Florida Statutes, hereby adopts the following Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company shall be: 4D Realty Group, LLC

ARTICLE II - ADDRESS

The principal place of business and mailing address of this Limited Liability Company shall be: 1123 NW North River Drive Miami, Florida 33136

ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

ARTICLE IV - DURATION

The Limited Liability Company shall exist in perpetuity.

ARTICLE V - MANAGEMENT

ARTICLE VII - MEMBERSHIP AND MEMBERSHIP INTERESTS OF MEMBERS

ARTICLE X – SHARING OF PROFITS AND LOSSES

Sharing of profits and losses shall be allocated on the basis of each member's membership interest in the Limited Liability Company.

ARTICLE XI - VOTING

Members of the Limited Liability Company are entitled to vote on matters concerning the Limited Liability Company and each member's vote shall be weighted in accordance with each member's membership interest in the Limited Liability Company.

ARTICLE XII - WITHDRAWAL OF A MEMBER

The remaining members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company upon the death, retirement, resignation, expression bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company provided that the remaining embers operate the business of the Limited Liability Company in full compliance with these Articles of Organization, the regulations of the Limited Liability Company and all applicable local, state, and federal laws.
