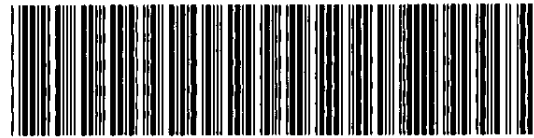

**ARTICLES OF ORGANIZATION
OF
A LA PROVENCE, LLC**

The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

ARTICLE I

Name and Address of Company

The name of the limited liability company (hereinafter referred to as the "Company") is A La Provence, LLC. The Company's street and mailing address 1415 Timberlane Road - Suite 215, Tallahassee FL 32312.

ARTICLE II

Commencement and Duration of Company

The Company shall exist from the date of filing these Articles with the Florida Department of State until the occurrence of any of the events specified in Section 608.441, unless continued by the unanimous consent of all of the remaining members.

ARTICLE III

Management

The Company's initial manager until the first annual meeting of the membership or until his successor is elected and qualified: William L. Termination of Membership

If a member of the Company dies, retires, resigns, is expelled, declared insane, becomes bankrupt, is dissolved or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by

Operating Agreement and Regulations

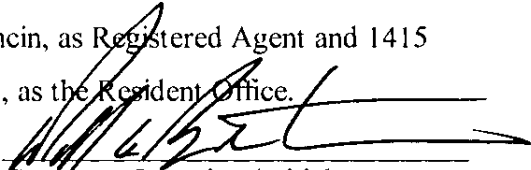

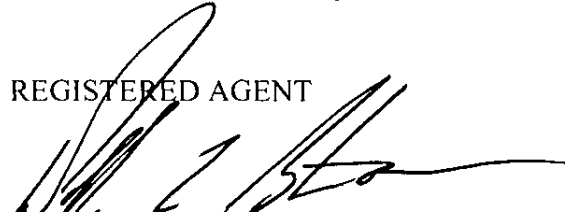
