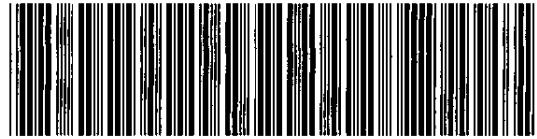

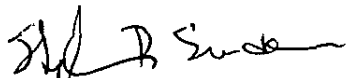

The principal office address and mailing address of the Limited Liability Company is **6653 Powers Avenue, #242, Jacksonville, Florida 32217**.

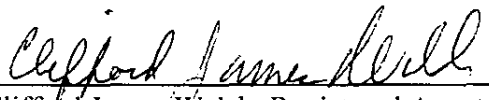

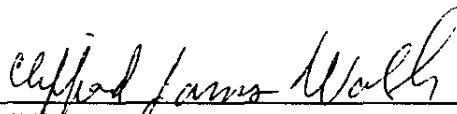
