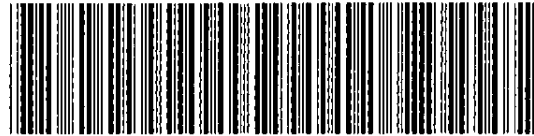

Article Two Registered Agent

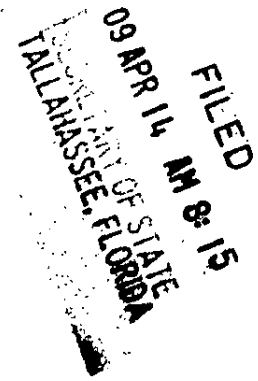

Article Three Principal Office




