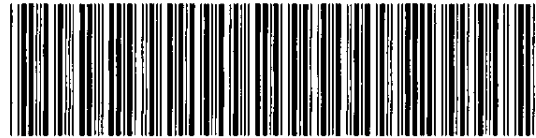

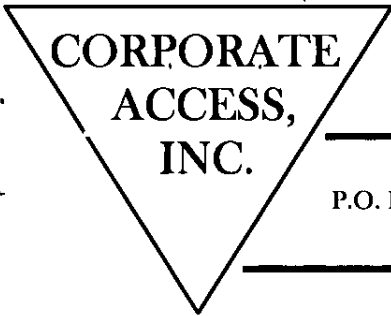

ARTICLE IV - PURPOSE



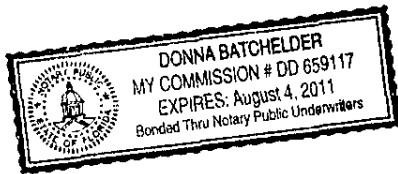
