ARTICLES OF ORGANIZATION OF JAFFE MEDICAL OF MICHIGAN, LLC

The undersigned, being a duly authorized representative of a Member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is Jaffe Medical of Michigan, LLC (the "Company").

ARTICLE II

ADDRESS

The principal office and mailing address of the Company

ARTICLE III

REGISTERED AGENT AND OFFICE

ARTICLE VI

PURPOSE

The purpose for which the Company is being formed to engage in any activity or business permitted under the Naws of the United States and the State of Florida.

ARTICLE VII

ADDITIONAL MEMBERS

Additional Members may be admitted upon the approval of a majority of the ownership interests of the Company, upon the written application of such new Member, in the manner set forth in the Operating Agreement of the Company.

ARTICLE VIII

OPERATING AGREEMENT

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company in the manner set forth in the Operating Agreement of the Company.

ARTICLE IX

GOVERNING PROVISIONS

In the event of any conflicts between the terms and conditions of these Articles of Organization and the Company's Operating Agreement or similar organizational documents, the terms and conditions of the Company's Operating Agreement shall govern, but only to the extent of any such conflicts.
