#### ARTICLES OF ORGANIZATION OF

#### EN ROSEDALE, LLC

The undersigned, desiting to form a Limited Liability Company, pursuant to Florida Statute Chapter 608, regarding Limited Liability Companies, does hereby certify as follows:

#### ARTICLE I Name

The name of said Limited Liability Company shall be EN ROSEDALE, LLC.

## ARTICLE II Principal and Mailing Address

## ARTICLE III Duration
