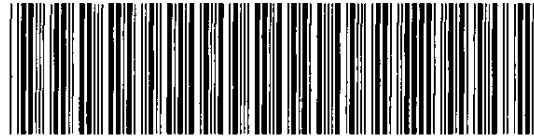

6. Management of the Company. The management of the Company shall be vested in the managers of the Company. The initial manager of the Company is Jeffrey I. Wooley.


