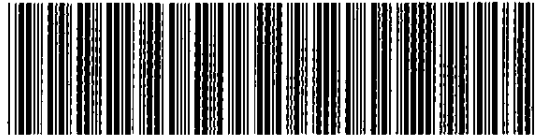

**ARTICLES OF ORGANIZATION OF
PROFESSIONAL SERVICES FOR YOU, LLC**

**ARTICLE I
NAME AND PRINCIPAL PLACE OF BUSINESS**

**ARTICLE II
PURPOSES AND POWERS**

**ARTICLE IV
MEMBERSHIP RESTRICTIONS**
