Pursuant to the provisions of Section 608.411 of the Florida Limited Liability Company Act, **SIG I, LLC** adopts the following Articles of Amendment to its Articles of Organization:

**FIRST:** The name of the limited liability company is SIG I, LLC (the "Company").

**SECOND:** The Articles of Organization of the Company were filed with the Florida Department of State on April 16 2009, under Document Number L09000036852.
