ARTICLES OF ORGANIZATION

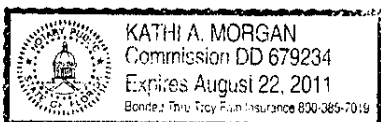


