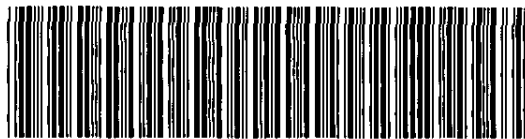

**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF  
SOUTHEASTERN ENTERPRISES OF THE BIG BEND, L.L.C.,
