MORELAND, M.D., a natural person competent to contract and a member of THE LABORATORY GROUP OF NORTHWEST FLORIDA, PLLC, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 608, *Florida Statutes*.

ARTICLE I

The name of the professional limited liability company is:

This professional limited liability company is referred to in these articles of organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
