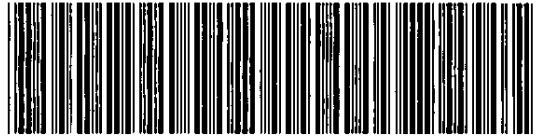

4. The amendment of the article of organization was approved by all members on September 9, 2009. The number of votes cast for the amendment was sufficient for approval.

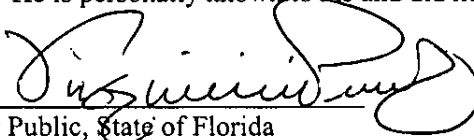
