If Chapter of the Florida Statutes is hereafter amended to authorize the further elimination or limitation of the liability of the governors, then the liability of a governor of this Limited Liability Company, in addition to the limitation on personal liability provided herein, shall be limited to the fullest extent permitted by the Florida Statutes, as amended. Any repeal or modification of this Article by the members of this Limited Liability Company shall be prospective only and shall not affect any limitation of the personal liability of a governor of this Limited Liability Company existing at the time of such repeal of modification.

ARTICLE VIII ACTIONS BY WRITTEN CONSENT

Any action which is required or permitted to be taken by the governors of this Limited Liability Company at a meeting and which does not require the approval of the members may be taken by written action signed by the number of governors that would be required to take the same action at a meeting at which all governors were present. However, if the action is one which must be approved by all members, such action may be taken only by written action signed by all of the governors then in office. Any action required or permitted to be taken at a meeting of the members may be taken by written action signed by the members who possess the voting power that would be required to take the same action at a meeting of the members at which all members were present.
