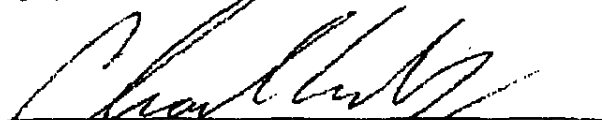
ARTICLE VII
