FLORIDA RESTAURANT GROUP, LLC**


Pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State, the following are the Articles of Organization for FLORIDA RESTAURANT GROUP, LLC (the "Company"):

1. Name. The name of the Company is FLORIDA RESTAURANT GROUP, LLC.
2. (a) Mailing Address. The Company's mailing address shall be P.O. Box 50648, Jacksonville Beach, Florida 32250.
