ARTICLES OF ORGANIZATION OF REGIONAL DEVELOPMENT-CHESAPEAKE, LLC

Pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State, the following are the Articles of Organization for Regional Development-Chesapeake, LLC (the "Company"):

- 1. <u>Name</u>. The name of the Company is Regional Development-Chesapeake, LLC.
- 2. <u>Mailing Address and Principal Place of Business</u>. The Company's mailing address and principal office shall be located at 3030 Hartley Road, Suite 350, Jacksonville, Florida 32257.
