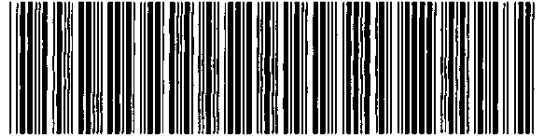




ARTICLE VIII
