The undersigned hereby certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit and hereby adopt the following Articles of Organization for such limited liability company:

ARTICLE I
NAME AND PRINCIPAL OFFICE

The name of this limited liability company is JP MCTYRE, LLC and its principal office and mailing address is located at 13324 Falcon Pointe Drive, Orlando, Florida 32837.

ARTICLE II
DURATION

The existence of this limited liability company shall be perpetual, commencing upon the filing of the Articles of Organization by the Florida Department of State.

ARTICLE III
PURPOSE

The purpose of this limited liability company is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV
MEMBERSHIP

The members of this limited liability company have the right to admit additional members to this organization upon the unanimous consent of those individuals or entities who are members prior to the admission of the new members.

ARTICLE V
DISSOLUTION

The limited liability company will dissolve as provided in the Operating Agreement executed by and among its members.

**ARTICLE VI

This organization is to be managed by a manager or managers elected by a majority vote of its members. The initial managers, who shall serve until the earlier of their death, resignation, replacement or until the first annual meeting of members and their successors are elected and qualified, shall be JOHN MCTYRE and PATRICIA MCTYRE.

**ARTICLE VII
INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of this limited liability company shall be located at 13324 Falcon Pointe Drive, Orlando, Florida 32837, and the initial registered agent of the limited liability company at that address shall be JOHN MCTYRE.
