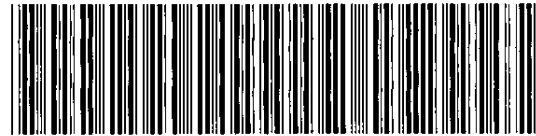

ARTICLE V


