ARTICLE VIII - INFORMAL ACTION OF MEMBERS



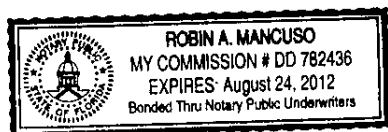


