ARTICLES OF ORGANIZATION

OF

ZELE HUBER, P.L.

The undersigned, for the purpose of forming a professional limited liability company under the Florida Professional Service Corporations and Limited Liability Companies Act, F.S. Chapter 621, and the Florida Limited Liability Company Act, F.S. Chapter 608, as applicable and to the extent not in conflict with Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **ZELE HUBER, P.L.** ("Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be 240 Sedona Way, Palm Beach Gardens, FL 33418.

ARTICLE III - PURPOSE
