ARTICLES OF ORGANIZATION
of
4480 N. FEDERAL HIGHWAY, L.L.C.

The undersigned, being a duly authorized person, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I
DURATION

4480 N. Federal Highway, L.L.C. shall exist perpetually or until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.

ARTICLE II
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be 4480 N. Federal Highway L.L.C., and its principal and mailing office shall be located at 5191 Sabal Gardens Lane No. 2, Boca Raton, Florida 33487, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE III

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.




