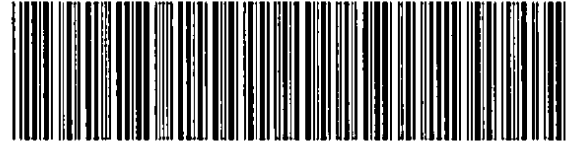

Pursuant to Florida Statute 608.445, the undersigned limited liability company adopts the following Articles of Dissolution for the purpose of dissolving the company:



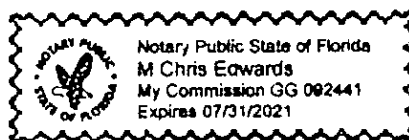




STATEMENT OF INTENT TO DISSOLVE
