**ARTICLES OF ORGANIZATION
OF
INAM INTERNATIONAL MARKETING 2, LLC**

The undersigned, being a duly authorized representative of the members, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopts the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is INAM INTERNATIONAL MARKETING 2, LLC (the "Company").

ARTICLE II

ADDRESS

ARTICLE III

The manager shall serve in such capacity until their successor(s) are duly elected and qualified.

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company in the manner set forth in the Operating Agreement of the Company.


